- Interested party comments following project presentations shall be no longer than five minutes in length. DMMO agencies may ask clarifying questions of project proponents and commentators.
  - After all comments, project proponent may respond to public comments.
- Interested parties may ask questions or make comments during DMMO discussions before DMMO recommendation is made. Formally close comments before DMMO makes final recommendation.
- Written comments are encouraged and must be regarding DMMO issues or projects.
